BE IT RESOLVED, by the Council of The City of San Diego as follows:

WHEREAS, the California Council on Criminal Justice may consent to review for possible funding of the project submitted by The City of San Diego referred to as Southeast Involvement Project; NOW, THEREFORE,

BE IT RESOLVED, that the City Manager be, and he is hereby authorized to submit to the California Council on Criminal Justice on behalf of The City of San Diego, the application for grant for law enforcement purposes, said form of grant application on file in the office of the City Clerk as Document No. 740851.


BE IT FURTHER RESOLVED, that in the event the California Council on Criminal Justice consents to fund the above project, The City of San Diego agrees to accept the grant and designates the City Manager to execute on behalf of The City of San Diego the contract for the grant for law enforcement purposes.

BE IT FURTHER RESOLVED, that The City of San Diego agrees to provide the required matching funds to said project, and the City Manager is hereby authorized to submit an amendment to the Fiscal Year 1973 Appropriations Ordinance to add \$18,000 to the Department of Human Resources budget for this purpose.

BE IT FURTHER RESOLVED, that grant funds received hereunder shall not be used to supplant ongoing law enforcement expenditures.

BE IT FURTHER RESOLVED, that Resolution No. 204957, adopted February 22, 1972, be rescinded.
