

RESOLUTION NO. 206201 AUG 8 1972

APPROVING MAP OF CROSSROADS/MISSION VALLEY SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by THOMAS C. CLARKE, Registered Civil Engineer, and entitled "CROSSROADS/MISSION VALLEY Being a subdivision of Villa Lot 2 in University Heights, according to amended map thereof made by G. A. D'Hemecourt in Book 8, Page 36 et. seq. of Lis Pendens S.C.C. 12456 filed in the office of the County Recorder of San Diego County, a portion of Pueblo Lot 1118 of the Pueblo Lands of San Diego according to Map thereof made by James Pascoe in 1870, filed as Miscellaneous Map No. 36 in the office of the County Recorder of San Diego County, also a portion of Golden Gate Drive, formerly Garfield Avenue, as closed July 26, 1926 by Resolution No. 38572 of Common Council of The City of San Diego, all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public street, to wit: Camino Del Rio South for public purposes, and said street is hereby declared to be a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, those easements listed in paragraphs 1 and 2 of the certificate signed by the Owners for: sewer, water, and drainage facilities, and open space; as granted and shown on said map and subject to the conditions expressed therein.

BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication for public street those portions of Lots 4 and 5 marked "Reserved for Future Street" as shown on this map, under the provisions of Section 11616 of the Business and Professions Code.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated; that those easements listed in paragraphs 1 and 2 of the certificate signed by the Owners are accepted on behalf of The City of San Diego, a municipal corporation, as above stated; and said Council has rejected those portions of Lots 4 and 5 marked "Reserved for Future Street" shown on this map within this subdivision, as above stated.
