WHEREAS, pursuant to Resolution No. 205781, adopted June 8, 1972, the City Council of The City of San Diego formally recognized various employee organizations to represent employees in the established appropriate units in accordance with section XII of the Employer-Employee Relations Policy of said City; and


WHEREAS, the salary ordinance adopted for fiscal year 1973 contains new classifications created subsequent to establishment of appropriate units by the City Council; and

WHEREAS, it is now necessary that the newly adopted classifications be included in existing units as established by the City Council; NOW, THEREFORE;

BE IT RESOLVED, by the Council of The City of San Diego, that the new classifications contained in the salary ordinance for fiscal year 1973 be included in existing appropriate units as follows:

1. Supervisory Unit: Principal Property Agent;
2. Technical Unit: Neighborhood Recreation Leader;  
Lifeguard Trainee;
3. Maintenance and Labor Unit: Equipment Serviceman I;  
Equipment Serviceman III;  
Tree Maintenance Crewleader;  
Water Utilities Crewleader.
