

RESOLUTION NO. 206225

WHEREAS, a certain general utility easement was dedicated in Lots 4 through 9 of Block 13, College Park Unit No. 2, according to Map thereof No. 2218, filed August 10, 1937, in the office of the San Diego County Recorder; and

WHEREAS, the owner of the property has requested that the City vacate its interest in said easement to allow better utilization of the land; and

WHEREAS, The City of San Diego has never used this easement and the San Diego Gas & Electric Company and Pacific Telephone facilities have long been relocated and no longer need this easement; and

WHEREAS, a fee of thirty-five dollars (\$35.00) has been collected to cover the processing of this request; and

WHEREAS, said easement as hereinafter described is unnecessary for present or prospective public use by the City, and the City Manager recommends that the City vacate said general utility easement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That, pursuant to Section 50443 of the Government Code of the State of California, the general utility easement more particularly described hereinafter is hereby vacated:

The Southerly 6.00 feet of Lots 4, 5 and 6 and the Northerly 6.00 feet of Lots 7, 8 and 9 of Block 13, College Park Unit No. 2 according to the Map thereof No. 2218 filed on August 10, 1937 in the Office of the San Diego County Recorder.

That from and after the date of this order of vacation title to the land previously subject to said easement shall revert to the owner of the land free from the rights of the public.

BE IT FURTHER RESOLVED, that the City Clerk of said City be and he is hereby authorized and directed to cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the Recorder of said County of San Diego.
