WHEREAS, a certain sewer easement was granted to The City of San Diego by deed dated May 11, 1948, and recorded March 24, 1949, in Book 3150, Page 342 of Official Records of the San Diego County Recorder; and

WHEREAS, the owner of the property has requested that the City vacate its interest in said easement to allow better utilization of the land; and

WHEREAS, said sewer easement has never been used for the purpose for which it was granted since the date of filing of said deed to the present time and more than one year has elapsed; and

WHEREAS, a fee of thirty-five dollars (\$35.00) has been collected to cover the processing of this request; and

WHEREAS, said easement as hereinafter described is unnecessary for present or prospective public use by the City, and the City Manager recommends that the City vacate said sewer easement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That, pursuant to Section 50443 of the Government Code of the State of California, the sewer easement more particularly described hereinafter is hereby vacated:

That certain 4.00 foot wide sewer easement granted to the City of San Diego by Deed dated May 11, 1948 and recorded March 24, 1949 in Book 3150, Page 342 of Official Records of the San Diego County Recorder, being a portion of Lots 2 and 3 of Block 2, Bay Shore Addition, according to the Map thereof No. 1152, filed in the Office of said County Recorder.

That from and after the date of this order of vacation title to the land previously subject to said easement shall revert to the owner of the land free from the rights of the public.

BE IT FURTHER RESOLVED, that the City Clerk of said City be and he is hereby authorized and directed to cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the Recorder of said County of San Diego, and to transmit a copy of the recorded resolution to the Property Director for further handling.
