

RESOLUTION No. 206227

Adopted on AUG 8 1972

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That an easement for the purpose of a right of way for sewer purposes through, over, under, along and across the hereinafter described property be and the same is hereby set aside for such public purposes:

All that portion of Pueblo Lot 1247 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to map thereof made by James Pascoe in 1870, a copy of which map was filed for record in the Office of the San Diego County Recorder as Miscellaneous Map No. 36, on November 14, 1921, being an easement for sewer purposes 15.00 feet in width, lying 7.50 feet on each side of the following described centerline:

Commencing at the Southeast corner of Lot 3, University City Unit No. 9, according to map thereof No. 5100, on file in the Office of the San Diego County Recorder; thence North 77°24'49" East, 902.88 feet; thence South 11°27'55" West, 414.19 feet to the TRUE POINT OF BEGINNING; thence South 11°27'55" West 205.43 feet; thence South 46°48'43" West, 313.12 feet to a terminus.

The sidelines of said 15.00 foot strip of land shall be prolonged or shortened so as to terminate Northerly in the Southerly line of State Highway Route 52 and Southerly in a line which bears North 81°42'00" East, through the point of terminus.

The Basis of Bearings is the Easterly line of Lot 3, University City Unit No. 9, per Map 5100, i.e. N 13°18'00" E.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to file a certified copy of this resolution in the office of the County Recorder of San Diego County, and to forward a copy of the recorded resolution to the Property Director for further handling.
