

RESOLUTION NO. 206234 AUG 8 1972

WHEREAS, Section 1930 of the California Streets and Highways Code provides a procedure for the summary vacation of streets by city council resolution where those portions to be vacated have been superseded by relocation; and

WHEREAS, portions of Road Survey 98 and Road Survey 188 have been relocated through the approval and dedication on this date of a portion of Mary Ellen Road, as more particularly shown on drawing No. 15387-D on file in the office of the City Clerk as Document No. 740949; and

WHEREAS, those properties adjoining the portions of Road Survey 98 and Road Survey 188 to be vacated will continue to have access or will be accessible by the alternate route dedicated on this date; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Road Survey 98 in Section 5, T. 15 S., R. 2 W., S.B.B.M., and the West 1/2 of Section 32, T. 14 S., R. 2 W., S.B.B.M.; and Road Survey 188 in Section 5, T. 15 S., R. 2 W., S.B.B.M., and Section 32, T. 14 S., R. 2 W., S.B.B.M., as more particularly shown on drawing No. 15372-D on file in the office of the City Clerk as Document No. 740950, which said drawing is attached hereto and made a part hereof, be and the same is hereby vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

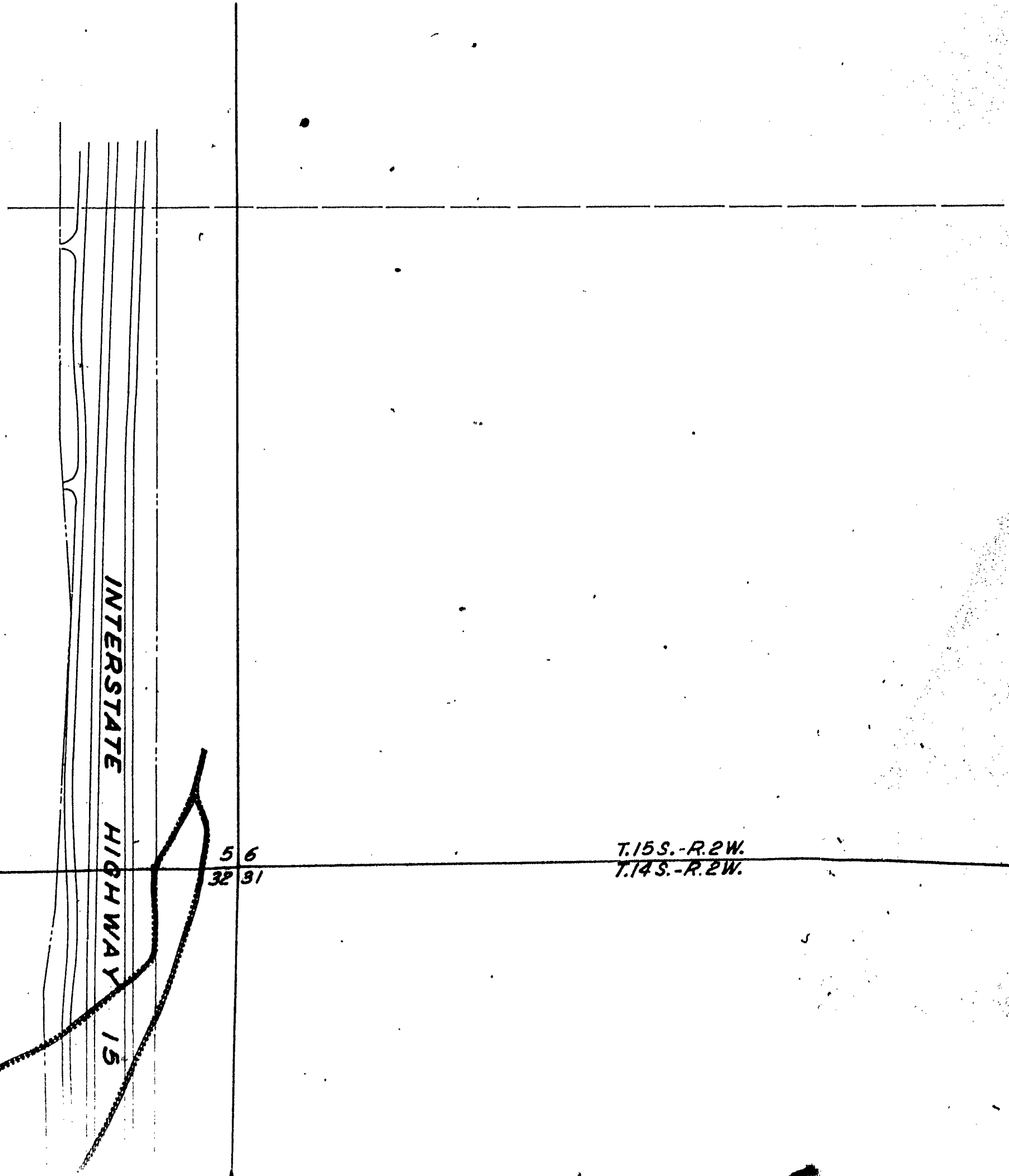

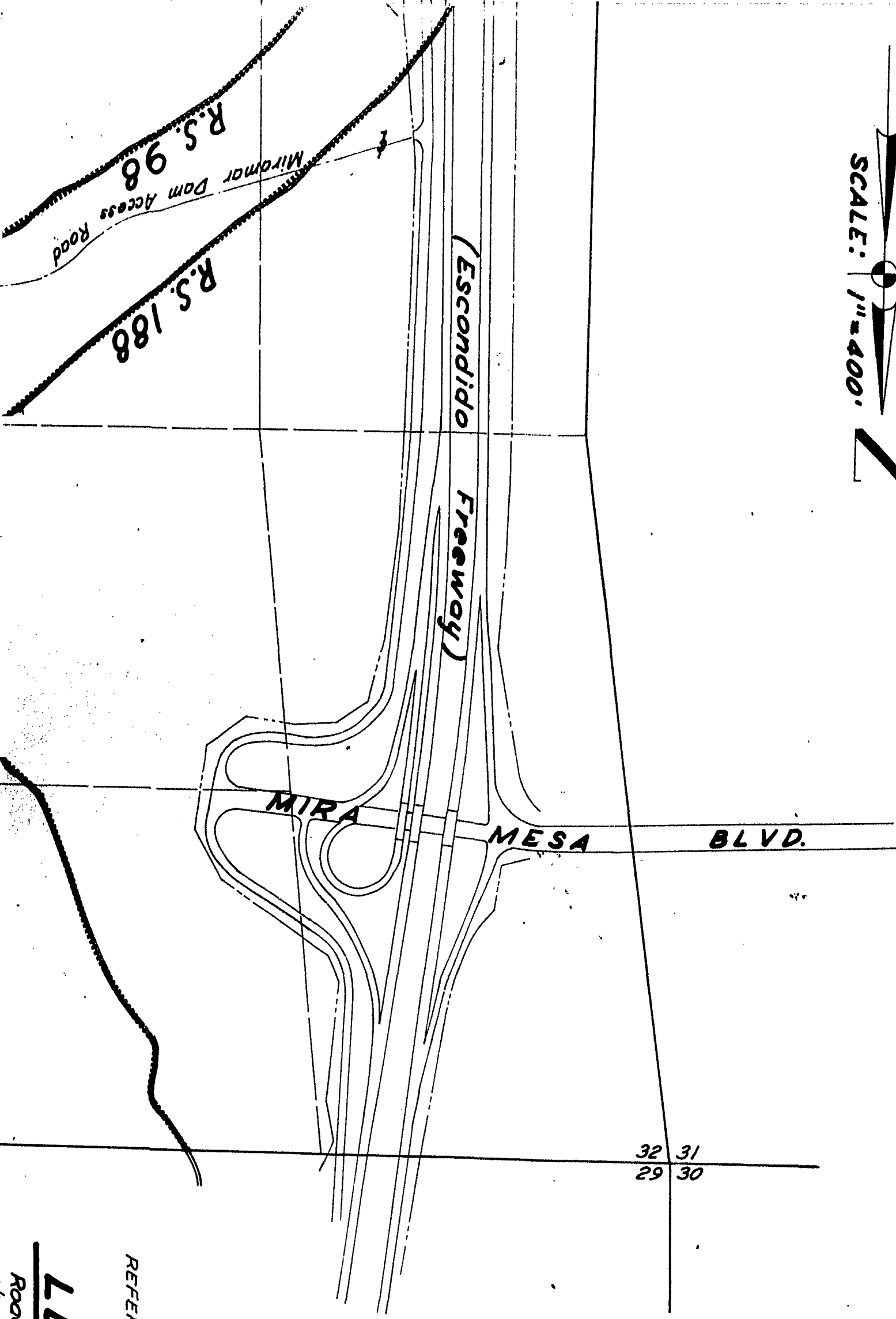

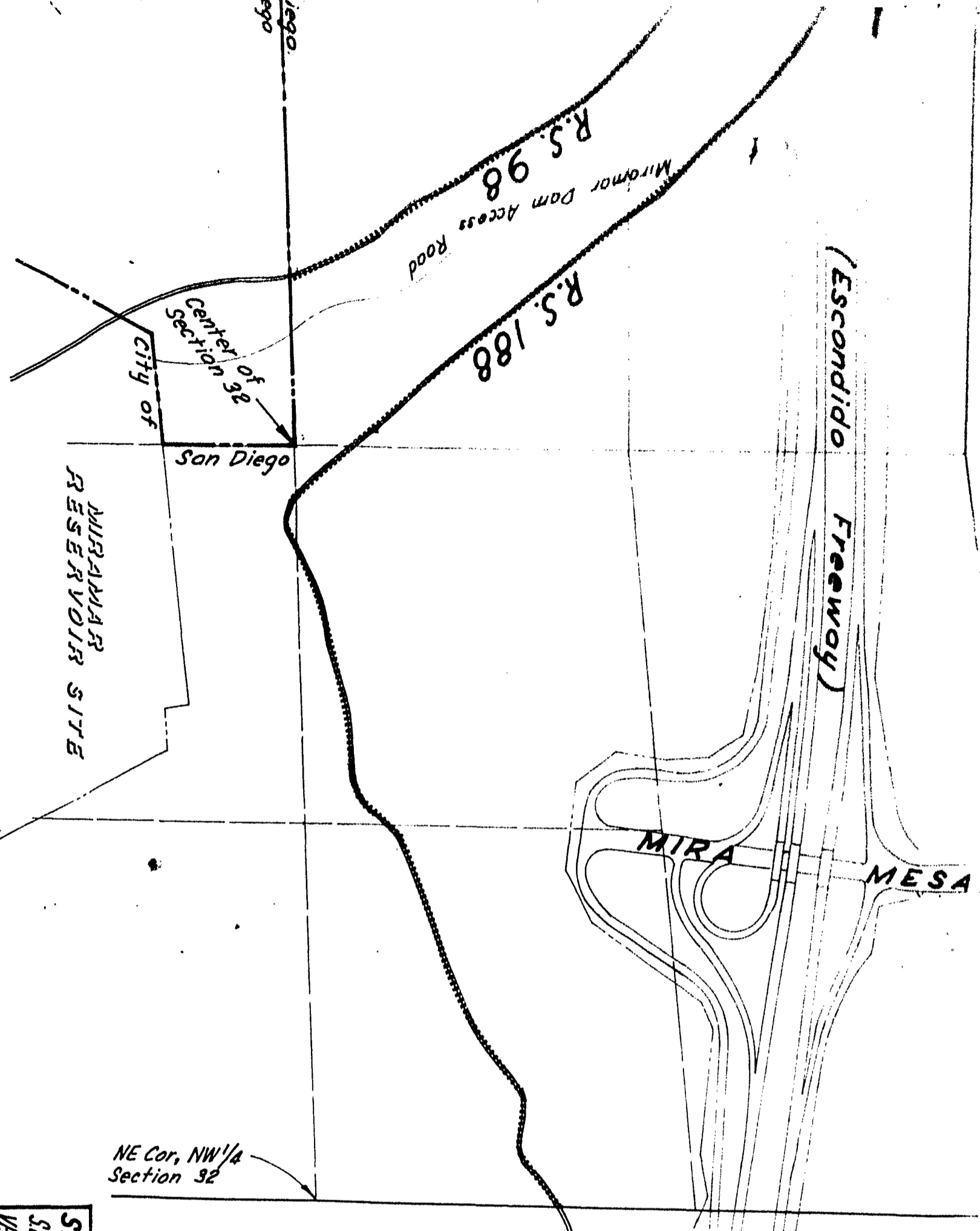
