
Adopted on AUG 8 1972

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with ASSOCIATED ENGINEERS, a California corporation, for engineering services in connection with the design of Black Mountain Road from Miramar Road to the south line of Rancho de los Penasquitos, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 740952.

BE IT FURTHER RESOLVED, that the expenditure of \$78,700 is hereby authorized from Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for the engineering services described above.
