RESOLUTION CONFIRMING THE ASSESSMENTS IN THE
MATTER OF SAN DIEGO STREET LIGHTING MAINTENANCE
DISTRICT NO. 1 (INCLUDING ANNEXED TERRITORY).

(SAN DIEGO STREET LIGHTING MAINTENANCE DISTRICT NO. 1)

WHEREAS, Resolution of Intention No. 205972, adopted June 29, 1972, declared this Council's intention to order the confirmation of assessments for the San Diego Street Lighting Maintenance District No. 1 (including that territory ordered annexed by Resolution No. 206240, adopted AUG 8, 1972); and

WHEREAS, on the date, time and place set forth in said resolution a public hearing was held with opportunity being given to those persons desiring to protest; and

WHEREAS, pursuant to Section 65.0230 of the San Diego Municipal Code the Council has considered and reviewed the costs to be assessed for the supplying of energy, maintenance and service for the ensuing year; and

WHEREAS, the proposed assessments for the said maintenance district are on file in the office of the Street Superintendent and have been made available for public inspection; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the assessments described in said Resolution of Intention No. 205972 and on file in the office of the Street Superintendent of The City of San Diego for San Diego Street Lighting Maintenance District No. 1 (including that territory

ordered annexed by Resolution No. 206240, adopted
AUG 8, 1972) are hereby confirmed and approved as
the amounts to be assessed to the individual properties within
the lighting district.
