WHEREAS, Resolution of Intention No. 205972, adopted June 29, 1972, declared this Council's intention to enter into a new contract with San Diego Gas & Electric Company for a one-year time period to provide electrical energy and switching to San Diego Street Lighting Maintenance District No. 1 (including annexed territory); and

Municipal Code a public hearing was held in conjunction with said
contract award; and

WHEREAS, this Council has considered all objections and protests made at said public hearing and has overruled and otherwise disposed of them; NOW, THEREFORE

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with San Diego Gas & Electric Company for the furnishing of electrical energy and switching for a period of one year to the San Diego Street Lighting Maintenance District No. 1 (including territory annexed by Resolution No. 206240 , adopted

, 1972) in the City of San Diego, under

the terms and conditions set forth in the form of agreement filed June 30, 1972, in the office of the City Clerk as Document No. 740420.
