WHEREAS, a temporary working area license is required to provide a working strip required for construction of the new 87-inch sewer main between pump station 2 on North Harbor Drive and the tunnel through the Government Reservation on Point Loma; and

WHEREAS, it will increase both the safety and the capacity of the Metropolitan Sewer System; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the acceptance by the City Manager of a license for a temporary working area prepared by the United States Government and required at the Naval Fuel Depot on Point Loma in connection with the construction of the 2nd Point Loma Force Main Sewer, be and the same is hereby approved.

2. That the expenditure of \$3,150 from Sewer Revenue Bonds Fund 728 is hereby approved solely and exclusively for the purpose of a license as more particularly described above.

3. That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said license to the Property Department for recording and further disposition.
