BE IT RESOLVED, by the Council of The City of San Diego as follows:

Sorrento Sand Co., Inc., are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of FERTILIZERS, SOIL AMENDMENTS, INSECTICIDES, HERBICIDES AND TOPSOIL as may be required for the period of one year beginning July 1, 1972 through June 30, 1973, per prices on file in the Purchasing Department, as follows:

1. Butler's Mill, Inc. for Items 9, 11, 12, 14, 15, 16, 17 and 19 of Section I; Items 7, 9, 10, 11, 12, 13 and 15 of Section II; and Item 1 of Section III; terms net 30 days, plus sales tax;
2. Wilbur-Ellis Company for Items 2, 3, 4, 6, 7, 8, 13 and 18 of Section I; and Items 2, 4, 5, 6 and 14 of Section II; terms net 30 days, plus sales tax;
3. Alco Chemical Co. for Items 1, 3, 8 and 16 of Section II; terms net 30 days, plus sales tax;
4. Ara Chem, Inc. for Items 1, 5 and 10 of Section I; terms net 30 days, plus sales tax;
5. Woodward Sand & Materials Co. for Item 2 of Section III; terms net 30 days, plus sales tax;
6. Sorrento Sand Co. Inc. for Item 3 of Section III; terms net 30 days, plus sales tax.
