


RESOLUTION No. 206280

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$20,604.00 by G. Spikes & W. Love Masonry & Cement Contractors, A Partnership, for the IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS IN THE AREA BOUNDED BY EVANS STREET, JULIAN AVENUE, SAMPSON STREET, HARRISON AVENUE, SICARD STREET, IRVING AVENUE, 28TH STREET, MARCY AVENUE AND KEARNY AVENUE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 740258.
2. That the expenditure of \$847,500.00 is hereby authorized out of the Gas Tax Fund (219) of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS IN THE AREA BOUNDED BY EVANS STREET, JULIAN AVENUE, SAMPSON STREET, HARRISON AVENUE, SICARD STREET, IRVING AVENUE, 28TH STREET, MARCY AVENUE AND KEARNY AVENUE in the City of San Diego, and related costs.
