WHEREAS, that Permit on file in the office of the City Clerk as Document No. 716400, authorized by Resolution No. 191729, adopted September 28, 1967 by the Council of The City of San Diego, authorized San Diego Gas & Electric Company to construct, maintain and use an overhead 12,000 volt power line installation for the distribution of electricity, over and across a portion of Pueblo Lot 190 of the Pueblo Lands of San Diego; and

WHEREAS, San Diego Gas & Electric Company is presently constructing a new substation on United States Navy property in Point Loma; and

WHEREAS, in connection with this project, the overhead electric extension covered by said Resolution 191729 is being removed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the termination of said Permit for overhead electrical purposes affecting Pueblo Lot 190, authorized by Resolution No. 191729, be and the same is hereby approved.
