


RESOLUTION No. 206311

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$ 5,554.00 by Wilcox Electric, Inc. dba Arrow Electric, A Corporation, for the CONSTRUCTION OF STREET LIGHTING SYSTEMS ON ROSECRANS STREET BETWEEN QUALTROUGH STREET AND KELLOGG STREET in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 740350.
2. That the expenditure of \$ 7,000.00 is hereby authorized out of the Capital Outlay Fund (245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF STREET LIGHTING SYSTEMS ON ROSECRANS STREET BETWEEN QUALTROUGH STREET AND KELLOGG STREET in the City of San Diego, and related costs.
