APPROVING MAP OF TONY SUBDIVISION


BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM S. KROOSKOS, Registered Civil Engineer, and entitled "TONY SUBDIVISION Being a subdivision of a portion of Lot 65 of Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California according to the partition map of said Rancho made in an action entitled 'Juan M. Luco, et al., vs. The Commercial Bank of San Diego, et al.,' on file in the office of the County Clerk of San Diego County, California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys, that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council does hereby accept on behalf of the public, the portion of street, to wit: portion of Mission Gorge Road for public purposes, and said portion of street is hereby declared to be a portion of public street and dedicated to the public use.

The Clerk of said City is hereby directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of public street is accepted on behalf of the public as heretofore stated.
