2. That the expenditure of \$42,000.00 is hereby authorized out of the Flood Control and Storm Drain Bond Fund (Fund 727) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF SAN YSIDRO STORM DRAIN in the City of San Diego, and related costs.
