NOTHOMB, Licensed Land Surveyor, and entitled "PENASQUITOS GREENS Being a subdivision of a portion of the Rancho De Los Penasquitos in the City of San Diego, County of San Diego, State of California, according to map accompanying the patent of said Rancho, recorded in the office of the County Recorder of San Diego County, in Book 2, Page 385 of Patents.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the street and portions of streets, to wit: Paseo Cevera, a portion of Carmel Mountain Road and a portion of Paseo Valdear for public purposes, and said street and portions of streets are hereby declared to be a public street and portions of public streets and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street and portions of public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access together with the easement with the right of ingress and egress for the construction and maintenance of sewer as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
