PHILLIPS, JR., Registered Civil Engineer, and entitled "MORENA PLAZA UNIT NO. 1 Being a subdivision of a portion of Lot 9, together with a portion of Cudahy Place as closed and vacated to public use of Cudahy's Subdivision according to Map thereof No. 4053, filed in the office of County Recorder of San Diego County January 9, 1959; and a portion of Pueblo Lot 263 of the Pueblo Lands of San Diego according to Map thereof made by James Pascoe in 1870; together with a portion of Weeks Avenue adjacent to said Lot 9, being portions of Pueblo Lots 263 and 271 and portions of Lots 1 through 16, Block B of Weeks Addition, Map No. 123, filed in the office of the County Recorder of San Diego County, June 10, 1887, as closed and vacated to public use, all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the street, to wit: Buenos Avenue for public purposes, and said street is hereby declared to be a public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated; and that the easement with the right of ingress and egress for the construction and maintenance of drainage and sewer facilities is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
