RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO REQUESTING THE CONSOLIDATION OF A SPECIAL MUNICIPAL BOND ELECTION TO BE HELD IN THE CITY ON NOVEMBER 7, 1972, WITH THE STATEWIDE GENERAL ELECTION TO BE HELD ON THE SAME DATE.

WHEREAS, this Council has commenced proceedings and intends to call a special municipal bond election in the City to be held on November 7, 1972, for the purpose of submitting to the qualified voters of the City two general obligation bond propositions as set forth in this resolution; and

WHEREAS, it is desirable that this special municipal bond election be consolidated with the statewide general election to be held on the same date and that within the City the election precincts, polling places, voting booths and election officials for the two elections be the same, and that the Board of Supervisors of the County of San Diego be authorized to canvass the returns of the special municipal bond election, and that the statewide general election and this special municipal bond election be held in all respects as if there were only one election; and

WHEREAS, this Council within the time required by law has or will adopt an ordinance calling for a special municipal bond election and consolidating it with the statewide general election; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. The Board of Supervisors of the County of San Diego is hereby requested to consolidate a special municipal bond election to be held in the City of San Diego on November 7, 1972, with the statewide general election to be held on the same date.
- 2. The exact form of the propositions to be voted upon at the special municipal bond election as such propositions shall appear on the ballot are as follows:

PROPOSITION CITY OF SAN DIEGO BALBOA PARK ELECTRIC BUILDING CASA DEL PACIFICO BOND PROPOSAL. To augment any funds available YES from private or public sources and to improve, develop and expand the historical, educational, and recreational services of The City of San Diego shall the City incur a bonded indebtedness in the principal amount of Five Million Dollars (\$5,000,000) to permit the acquisition, construction, or completion of a new structure NO to be known as Casa del Pacifico to replace the old Electric Building in Balboa Park?

PROPOSITION CITY OF SAN DIEGO BALBOA PARK FORD BUILDING AERO-SPACE MUSEUM BOND PROPOSAL. YES To improve, develop and expand the historical, educational, and recreational services of The City of San Diego shall the City incur a bonded indebtedness in the principal amount of One Million Six Hundred Seventy Thousand Dollars (\$1,670,000) to permit the modification, repair МО and rehabilitation of the Ford Building in Balboa Park for the purpose of relocating the Aero-Space Museum in said building?

The propositions shall be designated on the ballot by a letter printed on the left margin of the square containing the description of each measure as provided in Section 10231 of the Elections Code of the State of California.

- 3. The Board of Supervisors of the County of San Diego is hereby authorized to canvass the returns of this special municipal bond election and is requested to conduct the elections in all respects as if there were only one election using only one form of ballot.
- 4. The Board of Supervisors of the County of San Diego is requested to issue to all officers of the County charged with duties pertaining to the statewide general election, instructions to take any and all steps necessary for the holding of a consolidated election.
- 5. The City Clerk of The City of San Diego is hereby directed to file a certified copy of this resolution with the Board of Supervisors and Registrar of Voters of the County of San Diego.
