

RESOLUTION NO. 206349

WHEREAS, there were relinquished to The City of San Diego certain abutter's rights of access in and to Mission Gorge Road over and across a portion of Lot 279, San Carlos West Unit No. 6 according to Map thereof No. 5492 filed in the office of the San Diego County Recorder on November 6, 1964; and

WHEREAS, the owners of the property have requested that the City revert these abutter's rights of access in the property to allow better utilization of the land; and

WHEREAS, said abutter's rights of access are no longer needed by the City and should be reverted in the property; and

WHEREAS, it has been determined that all affected City departments have no objection to the reversion of said abutter's rights; and

WHEREAS, a fee of \$35.00 has been collected to cover the processing of this request; and

WHEREAS, the City Manager recommends that said access rights be reverted in the property; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be and they are hereby authorized and empowered to execute for and on behalf of, and as the act and deed of The City of San

Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 741065, to the OWNERS IN FEE SIMPLE OF RECORD of Lot 279, San Carlos West Unit No. 6, effecting the revestment of those abutter's rights of access to Mission Gorge Road of said Lot 279, San Carlos West Unit No. 6, heretofore relinquished to the City, more particularly described in said form of quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be and he is hereby authorized and directed to deliver said deed to the Property Director of said City for further handling.
