That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a first amendment to agreement with FERVER ENGINEERING COMPANY, a California corporation, for engineering services in connection with design and construction of the Miramar Road Bridge over the Atchison, Topeka and Santa Fe Railroad and the San Diego and Arizona Eastern Railroad bridge over 47th Street, which agreement is on file in the office of the City Clerk as Document No. 735963, under the terms and conditions set forth in the form of first amendment to agreement on file in the office of the City Clerk as Document No. 741071.

BE IT FURTHER RESOLVED, that the expenditure of \$5,000 is hereby authorized from Gas Tax Fund 219 for the engineering services described above and related expenses, and that Resolution No. 202656 be supplemented in this amount.
