WHEREAS, in the event a menace to the public health or safety is created by a calamity such as a flood, storm, fire, earthquake, explosion, accident, civil disturbance, riot, or other disaster; and

WHEREAS, it may become necessary for The City of San Diego to borrow equipment and supplies from the California National Guard and/or the United States Army for the purpose of assisting the City in handling such calamity; and


WHEREAS, the United States Army and California National Guard have procedures for lending equipment under such circumstances after first exhausting all civilian resources; and

WHEREAS, these agencies require a permanent resolution of the City assuring said agencies of reimbursement in the event of damage to or destruction of any equipment provided; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That in the event it becomes necessary for The City of San Diego to borrow equipment and supplies from the California National Guard and/or the United States Army in order to assist in handling any calamity and such equipment and supplies are damaged or destroyed, The City of San Diego will reimburse the lending agency the necessary costs.
