WHEREAS, the San Carlos Recreation Council has generously offered to contribute to The City of San Diego the sum of two hundred fifty dollars for the purpose of purchasing a scoreboard clock for the gymnasium/auditorium at the San Carlos Park and Recreation Center; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager of The City of San Diego hereby accepts the generous contribution of two hundred fifty dollars from the San Carlos Recreation Club and directs that said contribution be deposited in Fund 3021 and thereafter be matched by an additional two hundred fifty dollars from Capital Outlay Fund 245 from The City of San Diego to be used exclusively for the purpose of purchasing a scoreboard clock for the gymnasium/auditorium at the San Carlos Park and Recreation Center.

2. That the expenditure of five hundred dollars from Capital Outlay Fund 245 is hereby authorized for the purpose of providing funds for the purchase of a scoreboard clock for the gymnasium/auditorium at the San Carlos Park and Recreation Center.

3. That this Council does hereby commend the San Carlos Recreation Council for this act of civic generosity and does hereby publicly express on behalf of the citizens of this City a debt of gratitude to the San Carlos Recreation Council.
