APPROVING MAP OF RANCHO SAN CARLOS UNIT NO. 5 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:


Said Council hereby finds that that certain map surveyed by GARY L. MCCABE, Registered Civil Engineer, and entitled "RANCHO SAN CARLOS UNIT NO. 5 Being a subdivision of portions of Lots A, G and H of the partition of a portion of Lot 70 of Rancho Mission San Diego, in the City of San Diego, County of San Diego, State of California, according to map thereof made in action entitled 'San Diego Realty Company, a corporation, vs. Maria Y. Olvera De Toro, et al', said map being filed in the office of the County Clerk of said County in Civil Case No. 15191.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the streets, to wit: Ruane Street, Santar Avenue, Jennite Drive, Volclay Drive, Stoneview Court, Tuxedo Road, Crowley Court, for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those easements with the right of ingress and egress for the construction and maintenance of drainage facilities are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
