Adopted on AUG 29 1972

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$20,800 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego solely and exclusively for the purpose of providing funds for the acquisition of right of way for La Jolla Scenic Drive from 150 feet north of the intersection of La Jolla Scenic Drive and Soledad Mountain Road to Soledad Mountain, and Via Capri from Soledad Mountain to Hillside Drive in the Muirlands area of La Jolla, which is required in order to improve La Jolla Scenic Drive from a 20-foot wide street to an 80-foot wide street with 64 feet of paving from curb to curb, and to improve Via Capri from a 20-foot wide street to a 60-foot wide street with 40 feet of paving from curb to curb.
