APPROVING MAP OF KNOLLWOOD PARK SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and entitled "KNOLLWOOD PARK Being a subdivision of a portion of the West Half of Lot "F" of partition of a portion of Lot 70 of Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to Referee's Partition Map thereof made in an action entitled 'San Diego Realty Company, a corporation, vs. Maria Y. Olvera De Toro, et. al.,' Superior Court Civil Case No. 15191, filed in the office of the County Clerk of said County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the streets and portion of street, to wit: Hillandale Drive, Deep Valley Road, Deerfield Street, Deerwood Court, Deerrun Place, Deer Hollow Place, Canyon Slope Place, Doreen Road, Aedan Court, Doe Point, Thistle Court, and a portion of Mission Gorge Road, for public purposes and said streets and portion of street are hereby declared to be public streets and portion of public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of vehicular access in and to Mission Gorge Road and Jackson Drive, adjacent and contiguous to Lots 1 through 30 and Lots 41 through 48, all as shown on this map within this subdivision; together with the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities and slope rights, all as shown on this map within this subdivision and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication for public street those portions of Lots 111 and 112 marked "Reserved for Future Street" as shown on this map, under the provisions of Section 11616 of the Business and Professions Code.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of public street are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of vehicular access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities and slope rights as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above

stated; and said Council has rejected those portions of Lots 111 and 112 marked "Reserved for Future Street" shown on this map within this subdivision, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
