

RESOLUTION NO. 216414

AUG 31 1972

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where those portions to be vacated have been superseded by relocation; and

WHEREAS, portions of Road Survey 627 (Mission Gorge Road) and a temporary street easement (Hillandale Drive) have been relocated by the dedication on this date of the streets within the subdivision known as Knollwood Park by the acceptance of the final map of the subdivision; and

WHEREAS, the properties adjoining those portions of Road Survey 627 and the temporary street easement to be vacated will continue to have access or will be accessible by the streets which have been dedicated with the approval on this date of the subdivision to be known as Knollwood Park; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Road Survey 627 (Mission Gorge Road) southeasterly of Road Survey 1634, and a temporary street easement (Hillandale Drive) adjacent to Hill N' Dale Unit No. 2, both within Lot F, Partition of a portion of Lot 70, Rancho Mission of San Diego, as more particularly shown on Drawings Nos. 12896-B and 12897-B on file in the office of the City Clerk as Documents No. 741250 and No. 741251, which said drawings are attached hereto and made a part hereof, be and the same are hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawings, attested by him under seal, to be recorded in the office of the County Recorder.

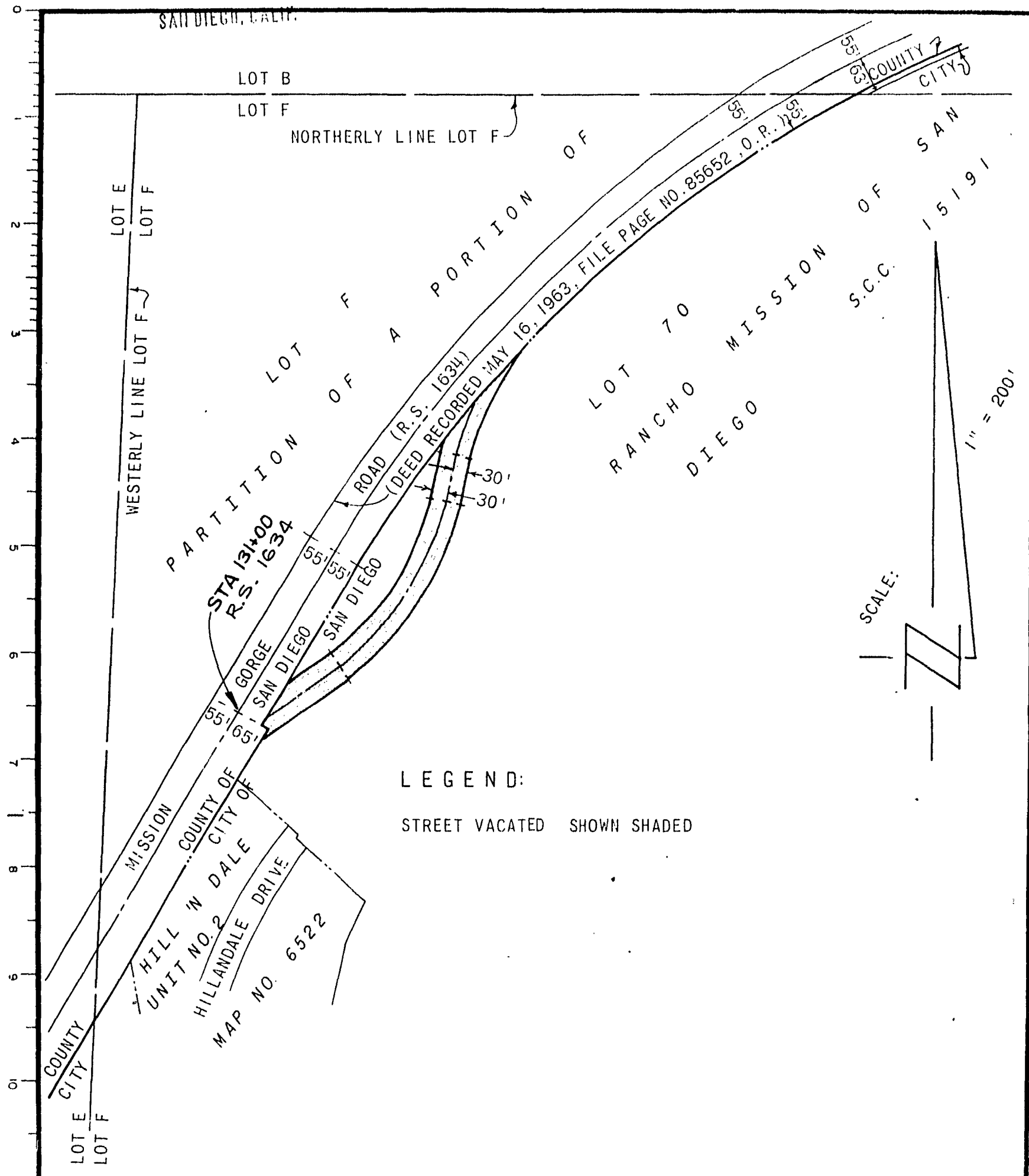

STREET VACATED SHOWN SHADED

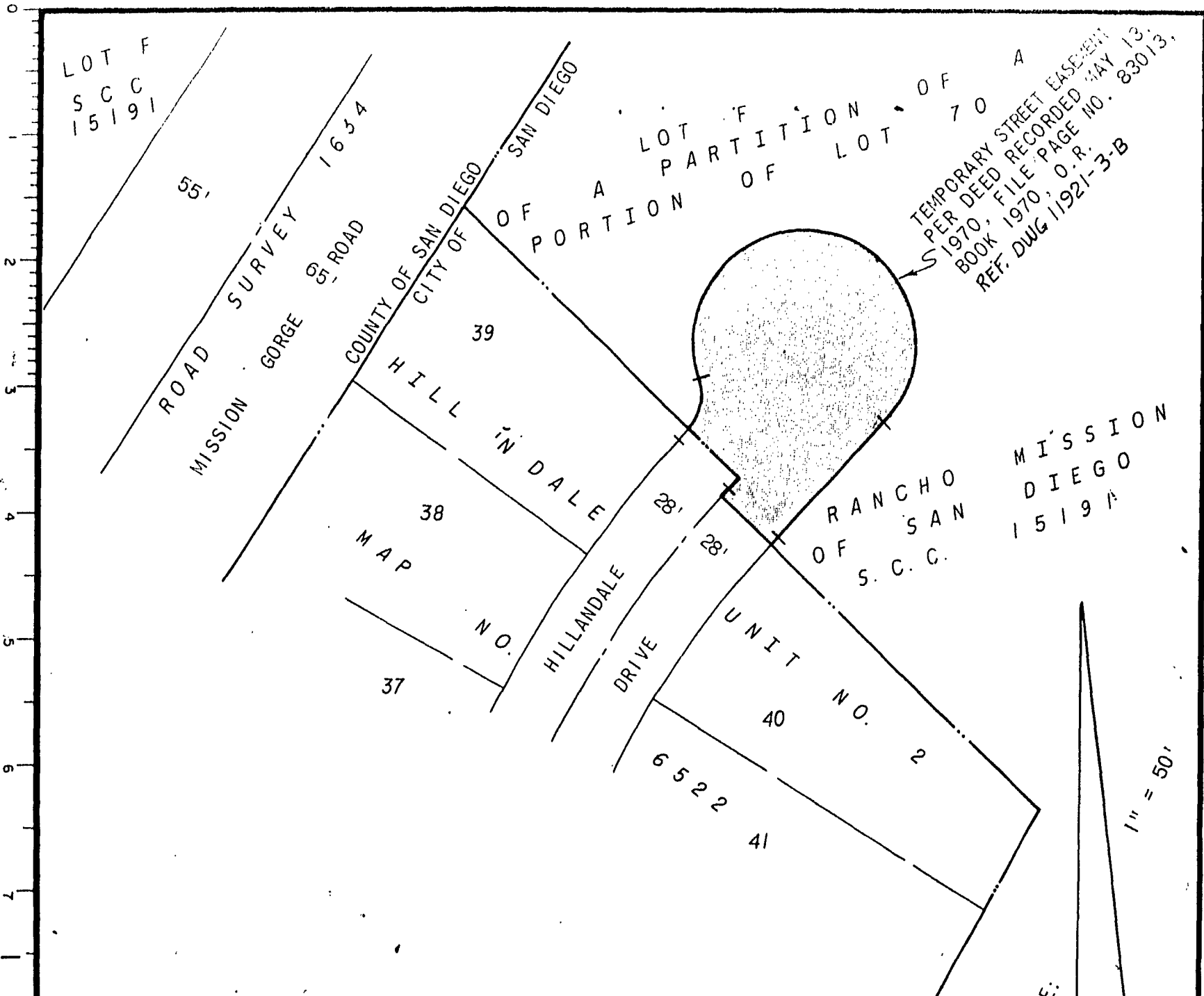
