

RESOLUTION NO. 206420

WHEREAS, LA JOLLA BEACH AND TENNIS CLUB, by H. Wm. Bond, Managing Director, filed a timely appeal with the City Clerk on August 14, 1972 with respect to a ten percent penalty imposed by the City Treasurer in accordance with Section 35.0108 of the San Diego Municipal Code; and

WHEREAS, said appeal was set for public hearing on August 31, 1972, in the Council Chamber at 9:30 a.m. and all parties were notified; and

WHEREAS, LA JOLLA BEACH AND TENNIS CLUB presented evidence at said hearing to the effect that the Transient Occupancy Tax had been deposited in a United States Post Office prior to midnight of July 31, 1972; and

WHEREAS, the City Council of The City of San Diego voted to overrule the assessment of the aforesaid penalty and to relieve the La Jolla Beach and Tennis Club of the liability to pay said penalty assessment; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the penalty assessment of \$515.86 levied by the City Treasurer is hereby voided and set aside and LA JOLLA BEACH AND TENNIS CLUB is and shall be relieved of any liability resulting from receipt by the City Treasurer of Transient Occupancy Tax from LA JOLLA BEACH AND TENNIS CLUB for the quarter ending June 30, 1972, by reason of the

imprint on the envelope remitting said Transient Occupancy
Tax bearing the date subsequent to midnight of the last
day for reporting and remitting the aforesaid tax.
