

RESOLUTION NO. 206434

APPROVING MAP OF ICE SKATING ARENA SUBDIVISION
AND RESCINDING RESOLUTION NO. 206053, ADOPTED
JULY 11, 1972.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and entitled "ICE SKATING ARENA Being a subdivision of a Portion of the South Half of the Southeast Quarter of Section 30, Township 14 South, Range 2 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to the United States Government Survey thereof approved August 29, 1890.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities and slope rights, as granted and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication for public street that portion of Lot 1 marked "Reserved for Future Street" as shown on this map, under the provisions of Section 11616 of the Business and Professions Code.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map; that those certain easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities and slope rights are accepted on behalf of The City of San Diego, a municipal corporation, as above stated; and said Council has rejected that portion of Lot 1 marked "Reserved for Future Street" shown on this map within this subdivision, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.

BE IT FURTHER RESOLVED, that Resolution No. 206053, adopted July 11, 1972 be, and it is hereby rescinded.
