The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivison map; that those certain easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities and slope rights are accepted on behalf of The City of San Diego, a municipal corporation, as above stated; and said Council has rejected that portion of Lot 1 marked "Reserved for Future Street" shown on this map within this subdivison, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.

BE IT FURTHER RESOLVED, that Resolution No. 206053, adopted July 11, 1972 be, and it is hereby rescinded.
