APPROVING MAP OF MESA VILLA SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:


Said Council hereby finds that that certain map surveyed by WILLIAM GREGORY CLARKE, Licensed Land Surveyor, and entitled "MESA VILLA Being a subdivision of all that portion of the Northeast Quarter of the Northeast Quarter of Pueblo Lot 1234 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to map thereof made by James Pascoe in 1870; a copy of which said map was filed in the office of the County Recorder of said San Diego County and is known as Miscellaneous Map No. 36, lying Northerly of the center line of Clairemont Mesa Boulevard, as said boulevard is described in Deed to The City of San Diego, recorded February 24, 1956 in Book 5990, Page 86 of Official Records.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved; and said Council accepts on behalf of the public, the alley for public purposes, and said alley is hereby declared to be a public alley and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of vehicular access in and to Clairemont Mesa Boulevard, adjacent and contiguous to Lot 1, all as shown and granted on said map.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public alley is accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of vehicular access as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
