WHEREAS, The City of San Diego is the owner of a certain easement for drain purposes affecting a portion of Lot 2, Dowdy's Subdivision Unit No. 2, according to Map thereof No. 6828 filed January 28, 1971, in the office of the San Diego County Recorder; and

WHEREAS, the owner of said Lot 2 of Dowdy's Subdivision Unit No. 2 has requested an exchange of easements to allow better utilization of the land; and

The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 741275, quitclaiming to the OWNERS IN FEE SIMPLE OF RECORD of Lot 2, Dowdy's Subdivision Unit No. 2, an existing easement for drain purposes affecting a portion of said Lot 2, Dowdy's Subdivision Unit No. 2, as more particularly described in said form of quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be and he is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director of The City of San Diego for further handling.
