VACATION OF KANE STREET, JELLETT STREET, THE ALLEY IN BLOCK 100, MORENA, AND A PORTION OF HARTFORD STREET.

BE IT RESOLVED, by the Council of The City of San Diego, California, that Kane Street and Jellett Street between Galveston and Hartford Streets, the Alley in Block 100, Morena, and a portion of Hartford Street adjacent to Block 100, Morena, as more particularly referred to in Resolution of Intention No. is unnecessary for present or prospective public street purposes.

BE IT FURTHER RESOLVED, that the public interest, convenience and necessity of said City requires the reservation of certain public easements, as more particularly referred to in Resolution 206348 of Intention No.

BE IT FUPTHER RESOLVED, that Kane Street and Jellett Street between Galveston and Hartford Streets, the Alley in Block 100, Morena, and a portion of Hartford Street adjacent to Block 100, Morena, as more particularly shown on Map No. 15163-D on file in the office of the City Clerk as Document No. which said map is attached hereto and made a part hereof, be and the same is hereby ordered vacated.

BE IT FURTHER RESOLVED, that The City of San Diego reserves and excepts from the foregoing vacation the permanent easements as more particularly described hereinafter:

Reserving and excepting to The City of San Diego the right, easement and privilege of placing, constructing, repairing, replacing, maintaining, using and operating both public utilities, including sewer, water and drainage facilities, and public walkways, together with all necessary and proper fixtures and equipment for use in connection therewith, through, over, under, upon, along and across the hereinafter described easements, together with the right of ingress thereto and egress therefrom, together with the right to maintain the said easements free and clear of anv excavation or fills, the erection or construction of any building or other structures, the planting of any tree or trees thereon, or the drilling or digging of any well or wells thereon, together with the right to otherwise protect from all hazards the operation and use of any right hereby reserved. Upon written permission of the City, the owners of the underlying fee may utilize the above described parcel of land for structures, the planting or growing of trees or the installation of privately owned pipelines.

The easements reserved herein are in, under, over, upon, along and across those portions of Kane Street, Jellett Street, the Alley in Block 100, Morena, and Hartford Street, vacated by this document, as more particularly shown on Map No. 15163-D on file in the office of the City Clerk as Document No. 741053

BE IT FURTHER PESOLVED, that the City Clerk shall cause a certified copy of this resolution attested by him under seal to be recorded in the office of the County Recorder.




