BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City an amendment to a lease agreement executed February 2, 1971, between the City of San Diego and Calimar, Inc., affecting Building Nos. 2010 and 2050 at Brown Field, said amendment to delete Building No. 2012 (also known as Building No. 12), to add additional vacant land adjacent to Building No. 2050, and to extend the term for eighteen (18) months and adjust the rental to \$1120.00 per month, under the terms and conditions set forth in the amendment to lease agreement on file in the office of the City Clerk as Document No. 741297.
