That Change Order No. 6, dated June 22, 1972, heretofore filed with the City Clerk of said City as Document No. 741338, issued in connection with the contract between The City of San Diego and Hood Corporation for the construction of additional sludge digestion facilities at the Point Loma Wastewater Treatment Plant, said contract having been filed as Document No. 733138, in the office of said City Clerk, be and the same is hereby approved; and the changes therein set forth, amounting to an increase in the contract price of \$18,636, and an extension of time of 120 days extending the completion to April 17, 1972, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$18,636 from the Sewer Bond Fund 728, be and it is hereby authorized solely and exclusively for the purpose of providing funds for the contract changes described above.
