BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the San Diego County Water Authority in connection with the location, design and construction of the Pomerado Pipeline, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 741301.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces the work to make end connections in conformance with the agreement with the San Diego County Water Authority, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City forces more economically than if let by contract.

BE IT FURTHER RESOLVED, that the expenditure of \$3,514,000 is hereby authorized from Water Revenue Fund 502 of The City of San Diego, solely and exclusively for these purposes and related costs.
