WHEREAS, The San Diego Transit Corporation submitted a budget to The City of San Diego and this Council asked on June 26, 1972, that a revised budget be prepared; and

WHEREAS, The San Diego Transit Corporation has not returned said revised budget to The City of San Diego as requested by this Council; and

WHEREAS, this Council deems it appropriate to subsidize The San Diego Transit Corporation for a limited time until such a budget may be examined and approved pursuant to the Operations Agreement the City has with The San Diego Transit Corporation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That a sum not to exceed two hundred thousand dollars (\$200,000) as a cash advance in furtherance of the Operations Agreement The City of San Diego has with The San Diego Transit Corporation be and it is hereby authorized as a subsidy to The San Diego Transit Corporation for operation during part of the 1972-73 fiscal year for public transportation purposes, and that the City Auditor and Comptroller is hereby authorized to advance such sum of \$200,000 to the San Diego Transit Corporation from Department 46, Public Transportation Fund 257, for said purposes.
