That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Second Amendment to Agreement with Geo-Testing, Inc., for subsurface exploration, testing and analysis of El Capitan Dam in connection with the possible repair or strengthening of said Dam, under the terms and conditions set forth in the form of Second Amendment to Agreement on file in the office of the City Clerk as Document No. 741383.

BE IT FURTHER RESOLVED, that the expenditure of an additional sum not to exceed \$2,583.30 above the \$33,600.00 originally allocated in Resolution No. 204002 is hereby authorized out of Water Revenue Fund 502 of The City of San Diego, solely and exclusively for this purpose.
