

RESOLUTION NO. 20650 SEP 19 1972

RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO,
CALIFORNIA, ORDERING ABANDONMENT OF PROCEEDINGS
(Cottontail Lane Assessment District)

WHEREAS, in proceedings pursuant to the Special Assessment Investigation, Limitation and Majority Protest Act of 1931 (commencing with Section 2800 of the Streets and Highways Code), the City Council adopted its resolution, Resolution No. 206063, determining the general nature, location and extent of the proposed work, and ordered the preparation of a report on said improvement, pursuant to said act; and, pursuant thereto, the City Manager has caused said report to be prepared, said report being on file with the City Clerk, Document No. 740572; and

WHEREAS, the Council by Resolution No. 206064 approved the report as filed, and appointed a time and place of hearing thereon; and

WHEREAS, notices of said hearing were duly mailed as provided by said act, and said hearing was duly continued from the date set forth in said notice of hearing, namely August 22, 1972, to September 19, 1972, at the hour of 9:30 o'clock A.M. in the Council Chambers of the City Council; and

WHEREAS, the Council finds that written protests were made and filed against the proposed improvements by the owners of more than one-half of the area of land to be assessed for the improvements, and that protests were not withdrawn so as to reduce the protest to less than a majority; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, California,

as follows:

Section 1. The Council hereby orders that said proceedings shall be and the same are hereby abandoned.
