BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by THOMAS E. CRAIG, Registered Civil Engineer, and entitled "OLVERA ESTATES Being a subdivision of portions of Lots 44 and 45 of Las Alturas Villa Sites, in The City of San Diego, County of San Diego, State of California, according to Map thereof No. 501, filed in the office of the County Recorder of San Diego County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council does hereby accept on behalf of the public, the portion of street, to wit: a portion of Olvera Avenue, for public purposes, and said portion of street is hereby declared to be a portion of a public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of public street is accepted on behalf of the public as heretofore stated.

the Clerk of the Board of Supervisors of the County of San Diego,
California.
