

RESOLUTION NO. 206568

SEP 21 1972

WHEREAS, this Council by Resolution No. 203069, adopted July 1, 1971, authorized the City Manager to submit a joint application, on file in the office of the City Clerk as Document No. 736410, with the County of San Diego for discretionary grant funds from the Law Enforcement Assistance Administration (LEAA) for \$385,000 to assist in the design and implementation of a coordinated records and communications system within the San Diego region; and

WHEREAS, as a portion of said application the amount of \$140,000 was specified for computer hardware and software to be used in The City of San Diego's Command and Control Center; and

WHEREAS, this requirement no longer exists and the Regional Steering Committee on Law Enforcement Records and Communications has recommended that these funds be reallocated for installation of a regional public safety hot line intercommunications system connecting police, fire and hospitals within the region; and

WHEREAS, for the reasons set forth above, it is now necessary to submit a modified application to the Law Enforcement Assistance Administration (LEAA); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized to submit and sign a joint application, for and on behalf of said City, with the County of San Diego for discretionary grant funds in the amount

of \$385,000 from the Law Enforcement Assistance Administration
for the design and implementation of a coordinated records and
communications system.
