

RESOLUTION NO. 206571

WHEREAS, The City of San Diego is the owner of a certain portion of Pueblo Lot 206 of the Pueblo Lands of San Diego; and

WHEREAS, it has been recommended by the Park and Recreation Board that said land be set aside and designated for park purposes; and

WHEREAS, the location of said property for park purposes is in accordance with the approved Peninsula Community Plan, the Park Service District Plan and the General Plan; and

WHEREAS, said designation is in accordance with Council Policy No. 700-17; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the hereinafter described real property be and the same is hereby set aside and designated for park purposes.
2. That the real property so set aside and designated is described in Exhibit A attached hereto.
3. That in the event of dedication of said real property as a public park, it shall be named "Collier Park West."

4. That the City Clerk of said City be and he is hereby directed to transmit a certified copy of this resolution to the Property Department for further disposition.

Legal Description

That portion of said Pueblo Lot 206 lying Westerly of the Westerly line of the 200.00 foot right of way of Nimitz Boulevard (formerly Wabaska Drive) as now located and established, and lying Southeasterly of the Southeasterly line of Soto Street as now located and established and lying Northeasterly of the Northeasterly line of Loma Alta No. 1 according to Map thereof No. 1078 filed in the office of the County Recorder of said San Diego County.

EXCEPTING therefrom that portion described as follows:

Beginning at the most Northerly corner of Block 11 of said Map No. 1078; thence Northeasterly along the Northeasterly prolongation of the Northwesterly line of said Block 11 to a line which is parallel with and 250.00 feet Northeasterly of and measured at right angles to the Northeasterly line of said Map No. 1078; thence Northwesterly along said parallel line to a line which is parallel with and 192.00 feet Southeasterly of and measured at right angles to the Southeasterly line of J. M. De Puys Subdivision of the West Half of the Northwest Quarter of said Pueblo Lot 206 according to Map thereof No. 30 filed in the office of the County Recorder of said San Diego County; thence Southwesterly along said parallel line to a line which is parallel with and 30.00 feet Northeasterly of and measured at right angles to the Northeasterly line of said Map No. 1078; thence Northwesterly along said parallel line to the Southwesterly prolongation of the Southeasterly line of said Soto Street as shown on Valeta Knolls according to Map thereof No. 3716 filed in the office of the County Recorder of said San Diego County; thence Southwesterly along said prolongation to the Northwesterly prolongation of the Northwesterly line of Block 11 of said Map No. 1078; thence Southeasterly along said prolongation to the Point of Beginning.
