<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
John E. Hoaglin	PUBLIC WORKS DEPARTMENT Buildings Div.	\$220	A new source of supply for policemen's batons was found that provides them at a much lower cost than those made by the City. Also a change in policy on their issuance to officers will result in a total saving of nearly \$2200 per year.
Paul Powell	PUBLIC WORKS DEPARTMENT Buildings Div.	\$200	This Carpenter designed a new type of so-called "busy boards", used for personnel sign-outs and telephone indicators, that are much more economical than the previous design. The saving on this popular item is estimated to be about \$2000 per year.
William W. Pfahler	POLICE DEPARTMENT	\$145	The Hit and Run Report form was changed as suggested to eliminate much of the time of both officers and clerical personnel involved in the procedures related to these reports. A net saving of \$1464 is estimated per year.
Hobart W. Cross	PURCHASING DEPARTMENT	\$105	When this suggester was a Senior Clerk in Utilities Customer Service, he proposed a change in computer programming for "no sign accounts" that would eliminate unnecessary trips to shut off water or remove meters. Customer relations are better too.
