


RESOLUTION No. 206574

1. That the bid of \$9,545.00 by G. Spikes & W. Love Masonry & Cement Contractors, a Partnership, for the IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS IN THE AREA BOUNDED BY 19TH STREET, COMMERCIAL STREET, 21ST STREET AND "L" STREET (E.D.A. Project No. 07-11-01227) in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 704717.
