That the bid of Industries Supply Co. is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of 5000 FEET OF 1" POLYETHYLENE PIPE at a cost of \$0.1646 per foot AND 3000 FEET OF 1½" POLYETHYLENE PIPE at \$0.3326 per foot for a total cost of \$1,820.80; terms 2% 10 days plus sales tax.
