APPROVING MAP OF PROSPECT PLACE SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:


Said Council hereby finds that that certain map surveyed by GUY W. WINTON, JR., Registered Civil Engineer, and entitled "PROSPECT PLACE Being a subdivision of Lots 8, 9, 10, 18, and 19 in Block 48 of La Jolla Park, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 352 filed in the office of the County Recorder of San Diego County March 22, 1887, excepting from said Lot 8 the Westerly 44.00 feet thereof.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the open space easement on a portion of Lot 1 as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that that open space easement is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to
the Clerk of the Board of Supervisors of the County of San Diego,
California.
