


**RESOLUTION No. 206582**

Adopted on SEP 26 1972

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute for and on behalf of said City a Lease Agreement with EDWARD L. OHLER and WILLIAM G. OHLER, for operation of a concession facility in Balboa Park for a term of ten years wherein City shall receive a rental of 10% of gross income resulting from the operation of the Concession Building, 15% of monthly gross income derived from certain specified mobile vending concessions, and 50% of monthly gross income from certain approved coin-operated vending machines, under the terms and conditions set forth in the form of Lease Agreement on file in the office of the City Clerk as Document No. 741434.
