Nancy J. Lovell	PUBLIC WORKS DEPARTMENT	\$90	A change in the method of recording the time spent by division personnel on special cost accounts was suggested by this Payroll Clerk. The improved method is estimated to save \$900 worth of time per year.
Charles C. Duschel	POLICE DEPARTMENT	\$20	This officer designed and made a new type of tire marking stick used by those engaged in parking enforcement. The stick has a spring in it that takes much of the strain off the arm; a strain that is considered to have caused tendonitis of the elbow.
Roy C. Mattson	PUBLIC WORKS DEPARTMENT Equipment Div.	\$10	The installation of a relay in the starter switch circuits of a certain make of trucks was proposed by this Mechanic to prevent maintenance caused by a voltage drop in these circuits. This is an initial award for what may be found to be a large saving after a year of experience with the use of this suggestion.
