

RESOLUTION NO. 206601

ADOPTED ON SEP 28 1972

BE IT RESOLVED by the Council of The City of San Diego, as follows:

1. That all bids heretofore received on August 17, 1972, pursuant to publication of notice calling for bids on TRAFFIC CHANNELIZATION AND MODIFICATION OF TRAFFIC SIGNAL SYSTEM AT NORTH HARBOR DRIVE AND RYAN MAIN GATE, DIP CORRECTION AT 35TH STREET AND ADAMS AVENUE, AND METAL BEAM GUARD RAIL ON RIVIERA DRIVE, ZOO PLACE, AND QUINCE DRIVE, are hereby rejected; and
2. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for TRAFFIC CHANNELIZATION AND MODIFICATION OF TRAFFIC SIGNAL AT NORTH HARBOR DRIVE AND RYAN MAIN GATE, San Diego, California, filed in the office of the City Clerk of The City of San Diego, California, on SEP 22 1972, and bearing official Document No. 741382, be, and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Council has ascertained the current or prevailing rate of per diem wages paid by private employers in the City for each craft or type of workman or mechanic needed to execute the contract, and does hereby declare that the wage scale included in said specifications is the said current or prevailing rate for the various crafts therein mentioned.

BE IT FURTHER RESOLVED, that the Purchasing Agent of The City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
